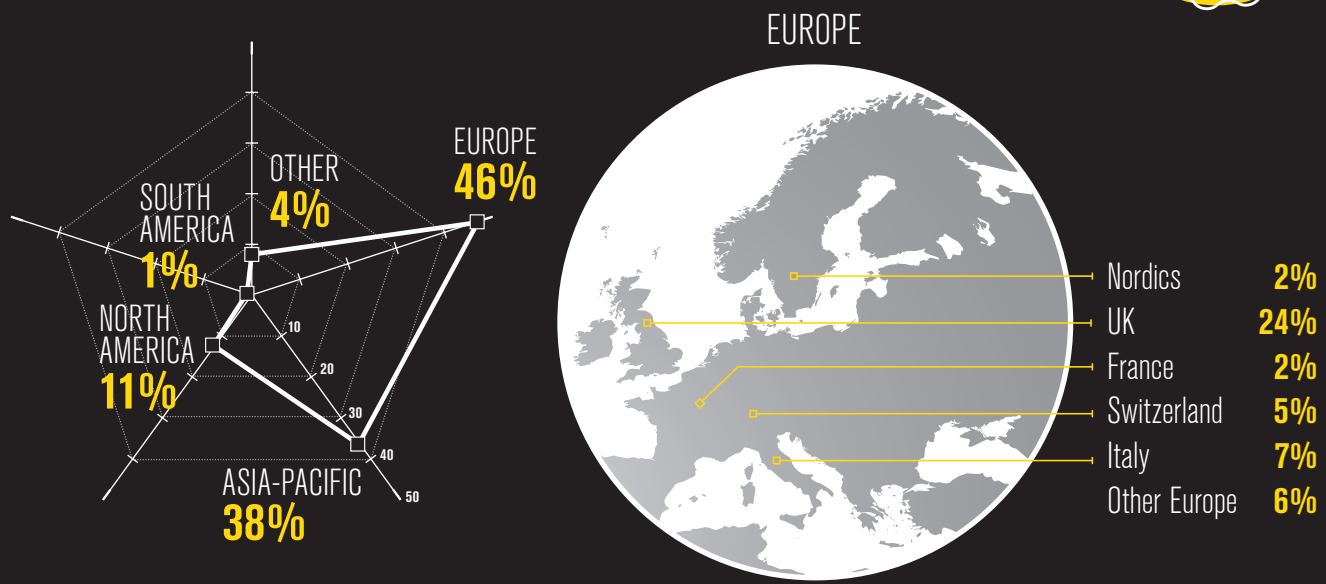

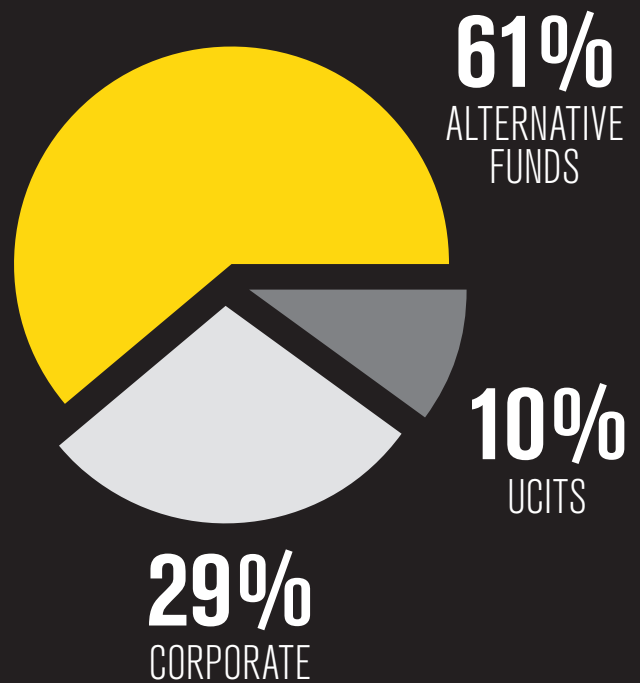
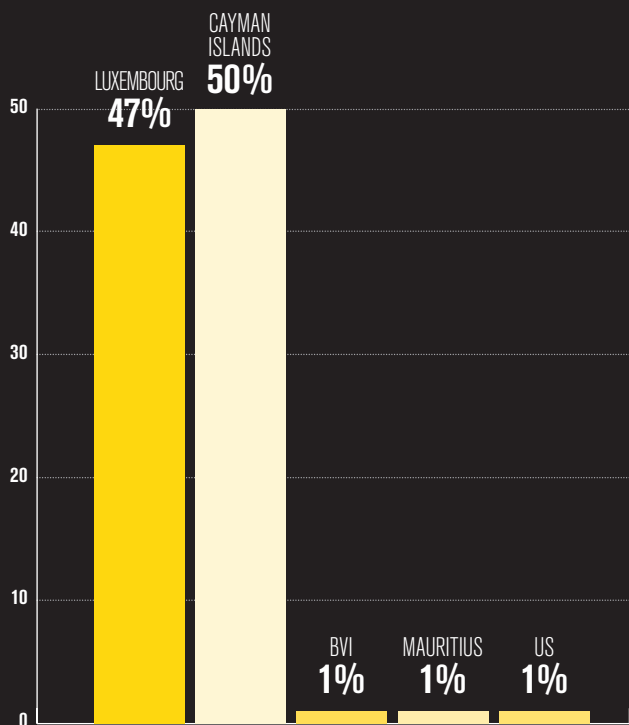
CLIENTS BY GEOGRAPHIC LOCATION

SINCE 2006



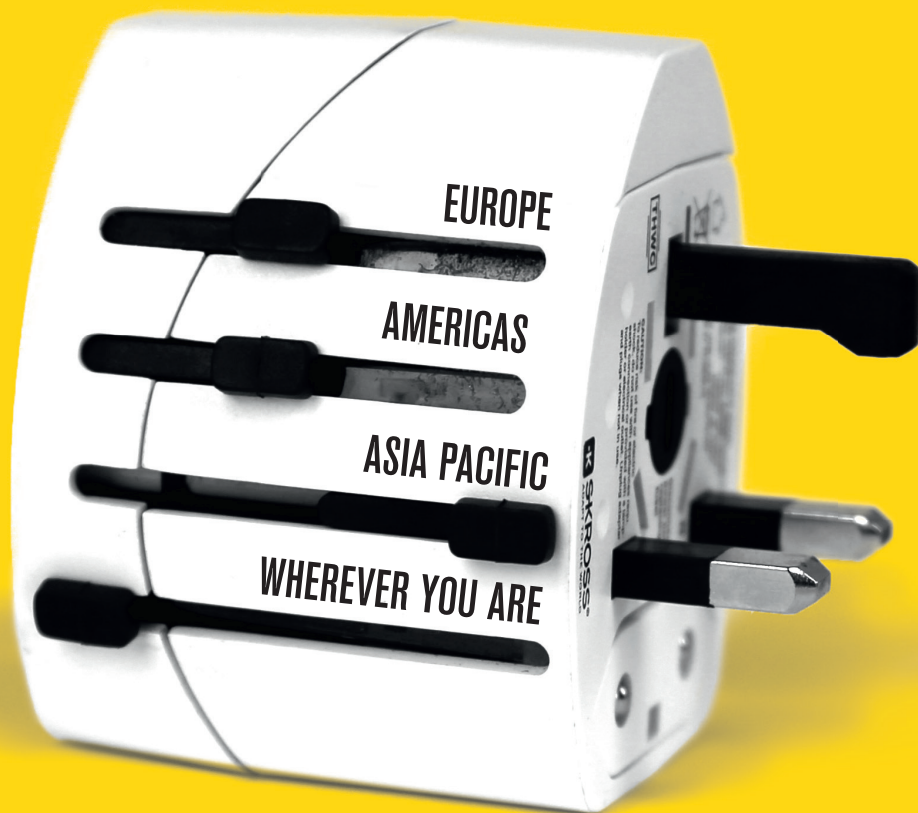
CLIENTS BY ENTITY JURISDICTION
